

RESOLUTION NO. 2021-56

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF APOPKA, FLORIDA, AMENDING THE BUDGET FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2021 AND ENDING SEPTEMBER 30, 2022, PROVIDING FOR A BUDGET AMENDMENT

WHEREAS, the City Council of the City of Apopka, Florida, has determined that the Budget for Fiscal Year 2021/2022 should be amended; and

WHEREAS, Florida Statutes, Section 166.241(4) requires the governing body amend the budgets in the same manner as the original budget is adopted; and

WHEREAS, the City Council adopted the final budgets for fiscal year 2021/2022 through resolution on September 15, 2021.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF APOPKA, FLORIDA, AS FOLLOWS:

SECTION 1: That the Budget for the City of Apopka, Florida, and Fiscal Year 2021/2022 is hereby amended for an amount totaling \$14,823,602.65 as indicated in the staff report which is attached hereto and made part of this Resolution by reference.

SUMMARY:

On September 15, 2021, by Resolution Number 2021-46 the City Council adopted the final budgets for fiscal year (FY) 2021-2022. The City has committed to expenditures and has experienced unanticipated revenues/expenditures through the current fiscal year that need to be reflected in the budget. Florida Statutes, Section 166.241(4) requires the governing body amend the budget in the same manner as the original budget is adopted. Below are the following proposed amendments:

4. Amendment: Florida Department of Transportation (FDOT) Resolution 2021-44 (US 441)

Funding Source: FY 2022 Streets Improvement Fund

Description: FDOT resurfacing, restoration, and rehabilitation of US 441 to extend the life of the existing roadway and to improve safety along the corridor. The City requested three additions to the project; median design prohibiting turns at six-legged intersections, installation of conduit under the road to the medians, and patterned pavement at the intersection of Central Ave. The City of Apopka is responsible for funding the patterned pavement at Central Ave. Resolution 2021-44 to execute a three-party escrow agreement was approved via the City Council meeting held on September 15, 2021.

5. Amendment: Apopka IDWTS Conversion Project

Funding Source: Reserves & SJRWMD Grant

Description: This amendment includes changes in revenues and appropriations related to the City of Apopka and the St. John's River Water Management district (SJRWMD) Florida Springs Grant Program. Seventeen (17) units will be installed at \$14,295 each, for a total cost of \$243,015. Of this total cost, the City will be responsible for \$60,754 and the remaining \$182,261 will be reimbursed by SJRWMD. Authorization of the 17 additional units was approved via the City Council meeting held on September 15, 2021.
