SUMMARY:

On September 15, 2021, by Resolution Number 2021-46 the City Council adopted the final budgets for fiscal year (FY) 2021-2022. The City has committed to expenditures and has experienced unanticipated revenues/expenditures through the current fiscal year that need to be reflected in the budget. Florida Statutes, Section 166.241(4) requires the governing body amend the budget in the same manner as the original budget is adopted. Below are the following proposed amendments:

1. Amendment: Fire Department emergency purchase of a 2022 Ford F-250 vehicle from Mullinax Ford. Funding Source: General Fund Reserves

Description: City Council agenda item referenced in today's meeting regarding the emergency designation and ratification for the Fire Department's purchase of a 2022 Ford F-250 Squad vehicle. The purchase is to replace the 2013 F250 Squad vehicle that is currently inoperable due to engine failure. Total dollar amount is \$48,850 plus a ten percent contingency.
